Independent Councillors push through Gaza motion in Kirklees

Independent Councillors in Kirklees who called on the local authority to condemn the indiscriminate attacks on Gaza by the Israeli military, saw a motion they presented pass, albeit by a single vote during an intense meeting full council meeting.

The motion submitted on behalf of councillors Darwan, Hussain, Moore, H Zaman, Bramwell, Safdar, Scott, Masood Ahmed, A Zaman, Daji, Kahut and Anwar asked the council to take "urgent action" on the conflict in the Middle East.

The Councilors called for significant and immediate aid and protection for Palestinians in Gaza who face imminent danger from hunger, disease, and military bombardment, look at a leadership change

Independent Councillors in Kirklees who alled on the local authority to condemn given to the Palestinian Authority.

Councillors also called for the Leader of the Council, Cllr Carole Pattison, to write to Prime Minister Keir Starmer, urging him to suspend both extant licenses for military equipment and technology, ensure Israel adheres to its obligations under international law.

The council was also urged to help ensure the Government uses use every diplomatic and economic lever at its disposal to help secure an immediate and permanent ceasefire, to stop the death and destruction, and to secure the safe release of hostages on both sides whilst also providing Significant and immediate aid and protection for Palestinians in Gaza who face imminent

danger from hunger, disease, and military bombardment. Furthermore, councillors also urged the Council to stop buying products from Israeli companies, who have illegally occupied Palestinian territories, and to ensure that goods and consumables sourced from companies directly or indirectly involved in the conflict are not used.

Councillor Zahid Kahut urged the Council to take heed and implement the motion. He said: "With just half an hour left before the end of the meeting, I amended the agenda and brought it forward. Cllr Ali Arshad gave an inspired speech along with Cllr Safdar. If it wasn't for Cllr Aziz daji, calling for a vote on the motion, this would not have gone through, so it really has been a team effort."



Council must follow up on Gaza motion

Cllr Kahut has called on the council to implement the motion.

"I would like to see a concerted effort by the council to implement the judgement. The council has a duty of care to deliver that motion, regardless of any contracts or potential issues, they will have to deliver on it. We will have to look at any potential issues on a case by case basis.

"It was nice for the council to have given Mayor Tracy brabin such an amount of time to deliver a speech.

"However, this has been a pressing matter for a long while and had we not acted quicker, especially Cllr Aziz Daji, who got up, objected and called for a vote, the motion may not have been passed. In addition, many people were not chained down by party whips or anything else, so we got there and got the motion passed, in the end. isreal has broken over 70 UN resolutions, enough is enough, this has to stop."

Independent Heckmondwike Councillor Ali Arshad, proposed the motion with a "heartfelt call to action" as he refused to "stand by silently" whilst urging councillors to "use our voices now."

He said: "It is easy to remember those lost when the time has passed, when the damage is done, but real remembrance through the honouring of those who are suffering before means using our voices now.

"While the suffering in Gaza is happening in real time, we don't want to stand there in years to come and say 'never again' to a crisis that we watched unfold and failed to confront when we had the power to speak out

"This isn't just a set of words on paper, it's a heartfelt call to action. It's a demand

for justice and compassion. Today we have the power to make a stand and to show that our council speaks for every resident who feels deeply for those affected in Gaza."

Batley East Councillor Aziz Daji, requested that the item be taken to a vote with this seconded by Cllr Cathy Scott (Community Alliance, Dewsbury East).

The motion was upheld with 27 votes for, 26 against and five members abstaining.

Mr Daji told Paigaam: "As an elected representative in Batley East, I need to challenge Kirklees Council to ensure that it is challenging both sides.

"As you will have seen from many protests across the vicinity, the residents of Batley East are greatly concerned about the situation in Gaza.

"We all want a ceasefire and we want it now. The killing of innocent people including many children and women needs to stop.

"This is what the motion called for," he said. Tanisha Bramwell, Independent Cllr for Dewsbury West hailed the fact that the motion was upheld, whilst calling for all Independent Councillors to stay united.

She said: "We successfully drafted, delivered, had our motion passed in full Council on Gaza. A massive achievement for our community.

"One that we have fought for over a year. In light of this, myself and Cllr Anwar want to take this moment to stress the need for unity amongst all independents. We must come together on key issues and stand strong against the current Cabinet on every decision impacting our residents."

Councillor Imran Safdar said Israel's bombing campaign cannot be seen as

collateral damage, but as ethnic cleansing.

He said: "Many of us as councillors

He said: "Many of us as councillors spoke up for hundreds of our residents across Yorkshire who share our concerns about the ongoing war crimes in Palestine.

"For many of us it's taken one year of blood, sweat and tears to get a pro BDS motion carried in Council that has some substance.

"The Motion has been submitted in accordance with Council Procedure Rule 14 as to Gaza - a year on, urgent action is needed.

"This Council calls on the Leader of the Council to write to Keir Starmer, the Prime Minister to urge him to revoke licenses which allow the selling of arms and military equipment to Israel until a time the Israeli Government stops the on-going genocide in Gaza, ceases to occupy the Palestinian Territories of the West Bank and Gaza, abides by the IJC rulings and the numerous United Nations resolutions.

"We urge the Prime Minister to lobby his Israeli counterpart to immediately allow in aid to Gaza unfettered by obstructions, in a bid to holt the humanitarian crisis that is occurring within Gaza. And that the Prime Minister uses all diplomatic channels at his disposal to call for a ceasefire and the return of the Israeli hostages

"We ask that Kirklees Council where at all lawful and practical to avoid purchases of goods from Israeli companies illegally occupying the afore mentioned Palestinian Territories.

"That the council commits to conducting a thorough review of its procurement practices to ensure that goods and consumables sourced from companies directly or indirectly involved in the conflict are not used." Mr Safdar also called out the hypocrisy of Western governments in relation to calling out Valdimir Putin's campaign against Ukraine whilst "turning the cheek" when it comes to Israel's crimes against the Palestinians in Gaza and the West Bank.

"He said: "On humanitarian rights, when we are supplying parts for bombers that are used to murder innocent Palestinian men, women and children, we cannot have one set of strong sanctions for one occupying, war criminal regime like the butcher Putin and then come up with a set of weak rules towards the government in Tel Aviv.

"Sanctions against Russia were implemented overnight and rightly so. The illegal invasion of Ukraine was wrong. The illegal occupation of the West Bank and Gaza is also wrong. We must listen to the ICJ.

"Councils like ours may seem like a small organisation but we are big organisations with big budgets. We must take action."

He also called on councillors to work hard in order to keep the trust of their constituents whilst calling on the powers that be to implement a Bosnia style international peace keeping force in gaza.

"This two-tier approach of both main parties has resulted in a loss of trust across our democratic system and for both our local and national leaders. In Gaza today, bodies are in pieces, hearts are in pieces and souls are in pieces.

"The reputations of our admired democracy, the democracy that I love is now in pieces. Where do we go after 17,000 infant deaths? Children dying, orphans all over the occupied territories, orphans who have cousins grieving in Bethlehem. What answers will our party leaders give in the future to those thousands of orphans and amputees?

"We as democrats must implore our government not to just call for a ceasefire but take boycott seriously. We must call for a Bosnia style international peace keeping force to protect children on both sides."

Benjamin Netanyahu must be arrested and International law must be upheld

Defence secretary Yoav Gallant must be held accountable for one of the gravest crimes of our age.

Why? Because of the sheer level of the evidence, showcased by Palestinian journalists, many of whom have been killed in the midst of the murderous mayhem around them.

The evidence in relation to war crimes and crimes against humanity seemingly met the threshold required to ensure the ICC's chief prosecutor, an independent panel of renowned lawyers and three international judges demonstrates that the strength of the case warrants Netanyahu amd Gallant's arrests.

Everyone who helped Israel plan and bomb so many Masjids, hospitals, women and children should not have the gaul to plead ignorance.

It is not just Netanyahu and Gallant who should be held to account before the likes of the Hague.sraeli leaders who have showcased their murder and theft throughout this unholy path of death and destruction are also guilty. These soldiers often posted their actions online, overwhelmed with glee and triumphalism as they did so.

In addition, western media outlets refused to frame their coverage around Israel's declarations of intent, failling to

Gallant would need to travel to a state that is a signatory to the ICC, which excludes the US.

However, Netanyahu may enjoy a level of immunity in foreign states because he is a head of government. However, the now sacked minister Gallant will not be able to bask in safety of such immunity.

At the very start of the bombing, Gallant insisted that Israel would impose a total siege on Gaza's population, whom he termed "human animals".

Gallant promised "Gaza won't return to what it was before." If that left room for subtlety, he declared: "Hamas won't be there. We will eliminate everything." He told Israeli soldiers that he had "released all the restraints" and "removed every restriction" on them.

One of his generals also threatened to unleash "hell" on the civilian population. Instead of reminding the Israeli's about their responsibilities and the rights of Palestinians, politicians helped facilitate it. The Biden administration offered \$12.5bn worth of aid since 7 October, and recently vetoed a ceasefire at the UN.

The White House has already come out to "fundamentally reject" the ICC's decision to issue arrest warrants. Israel has said Netanyahu would "not give in to pressure" in the war against Hamas and the Iranian "axis of terror". When the

MP submits Early Day Motion for Ukraine style Gaza visas

A Yorkshire based MP has called on the government to allow Palestinians in Gaza to come to the UK in a Ukraine style scheme like that has been offered in the past..

Labour's Rachael Maskell has submitted an Early Day Motion on the issue, attracting the support of Independent MP's including Shockat Adam, Ayoub khan, Apsana begum along with MPs from the Labour, Lib-Dem, Green, Plaid Cymru and SDLP parties, plus independents.

Her motion says more than 40,000 people in Gaza have died during the current conflict, with the number of injured far exceeding 100,000.

"The destruction of the Gaza's health infrastructure means that people cannot access vital medical attention," she said.

Ms Maskell believes a number of British Palestinains who would like to be united with their loved ones. She said: "There are a small number of Palestinians living in the UK whose loved ones are at imminent risk in Gaza."

Therefore, the motion "calls upon the Government to introduce a Gaza Family

Visa Scheme, based upon the Ukraine Family Scheme, to enable Palestinians from Gaza to reunite with their family members and seek temporary sanctuary in the UK until it is safe to return."

Ms Maskell said that although the world watched in horror as Russia invaded Ukraine, a number of Palestinians should be allowed in the UK, in order to showcase the UK values the lives of Palestinians alomng with those in Ukraine.

She continued: "We rightly enabled family members to immediately travel to the UK, and yet following the horrific assault by Hamas on 7 October 2023 which has resulted in at least 45,000 Palestinian civilians being killed, a similar scheme has not been established.

"My motion asks for a far more limited approach of family members, like my Palestinian constituent, who came to York to study at invitation of the British Council ahead of these terrible events, however has children left in Gaza.

"I am sure that no-one in York can imagine what it must be like to know that your little children could be killed at any point. A limited family visa scheme would

A Yorkshire based MP has called on Visa Scheme, based upon the Ukraine enable these families to be reunited and he government to allow Palestinians in Family Scheme, to enable Palestinians safe."

Ms Maskell added: "It is wrong to assume that little children would be Hamas supporters or pose terrorist threats, and therefore I am advocating for a secure, limited scheme to help families be together as we witness the most horrific atrocities be perpetrated against innocent civilians.

"We must recall that 70 per cent of those killed in Gaza are children and women, and for this reason my constituent should be able to see his family again, as should others."

However, York Outer Labour MP Luke Charters said he did not support the motion but did not comment further. Thirsk and Malton Conservative MP Kevin Hollinrake believes countries in the Middle East should offer such support, like Egypt and Syria.

He said: "Other countries are there, that would be more appropriate. It can't be the UK every time. We shared the responsibility with the rest of Europe with the Ukraine as neighbours. Why aren't they (Middle Eastern countries) taking similar responsibility?"



Report showcases intense Islamophobia across the UK

A report commissioned by the Runnymede Trust has revealed a notable increase in islamophobic crimes against Muslims.

The respected think-tank said explicit rhetoric portraying Muslims as a threat to British society is "divisive and derogatory."

The report also looked at the racist riots that took place across the UK this summer, stating that there is strong anti-Muslim sentiment across Britain.

"The way politicians talk about Muslims now is so derogatory, it's in the most brutally divisive terms," said Shabna Begum, the chief executive of the Runnymede Trust.

According to Begum, unless nothing changes in political rhetoric and UK policy, the riots which swept across the UK after an attacker who stabbed three children to death was mistaken for a Muslim immigrant, will take place again.

She also said that there was a "real reluctance to use the term Islamophobia during that period because politicians do not want to be seen "defending Muslims" and that they are partaking "in a popularity contest and that popularity contest is measured by how far they are willing to bully and demonise Muslims".

The report, endorsed by rights group Amnesty International Baroness Sayeeda Warsi, and the Muslim Council for Britain said over the last year, 38 percent of all religious hate crimes recorded by police were against Muslims, marking a 13 percent increase in hate crimes against Muslims.

The report also found that one in three Muslims students experience Islamophobic abuse, whilst it also found that in the NHS Muslims are referred to Prevent eight times more often than non-Muslims.

"For far too long, Muslims have been misrepresented and mistrusted, and the government's disengagement with Muslim civil society only serves to intensify the isolation of British Muslims," Baroness Warsi said.

"We need committed action to counter Islamophobia and to deal with the resurgence of far-right racism in Britain. That means ending the policy of disengagement, adopting a formal definition of Islamophobia and dealing with its various manifestations as described in this report," Warsi added.

The report showcases information which identifies the intensifying patterns of Islamophobia in British society, such as within educational institutions, mental

healthcare, and policing. It also details the May 2024 election campaign.

"Another finding in the report is that in the four months to February 2024, Tell Mama, an organisation which measures anti-Muslim attacks, recorded a 335 percent increase in hate attacks against Muslims compared with the previous year. Furthermore, the report states that the majority of the attacks were against women.

It further states that Muslims are more likely to reside in the most-deprived fifth of local authority districts, with around half a million more Muslims now living in the most deprived locales than in 2011. According to the report, Israel's war on Gaza may be linked to the spike in religious hate crimes.

Zara Mohammed, the secretary-general of the Muslim Council for Britain, praised the report and said there must now be a "robust strategy to tackle the deeply institutional and insidious nature of Islamophobia". "We need to move beyond the prevailing framework of securitisation and misleading narratives around integration.

"I commend the Runnymede Trust for providing this critical insight and urging the need for meaningful action" she continued.

However, it is such a vast country and the architecture was unbelievable, very beautiful.

"I visited a number of places throughout the country and also saw the border crossing ceremony on the border with Pakistan. "My husband has seen the border crossing from the Pakistan side as he's been to Pakistan before. My sketch pad sort of became my holiday diary. India has a certain character that makes it unique.

A local artist has donated a number This ensured I was able to combine things like geometrical patterns, beautiful cities, architecture and the people."

> Ann's paintings showcase a great deal of realism in capturing specific details, emphasising the many dominant and abstract visual elements of life in India. "My work combines realism; so the combination of stunning architecture along with the poorest of people isn't a stereotypical caricature. "Even the poorest of people have an intrinsic sense of pride in India and you quickly get used to it and you learn how to adapt. You end up developing a relationship between the people and the country as a whole, and what it is about India that gives it its character and makes it unique.

Imran Khan faces 'terrorism' charges after Islamabad protests

The Pakistani government has filed a series of charges, including one related to "terrorism", against former Prime Minister Imran Khan, his wife, Bushra Bibi, along with countless Pakistan Tehreek-e-Insaf (PTI) party workers who partook in protests against Mr Khan's detention in Islamabad.

Khan, Bibi and others have been accused of "terrorism", violations of a law that confines protests, attacks on police, abduction, interference in government affairs and defiance of Section 144, which prohibits gatherings of more than four people.

Authorities have already arrested nearly 1,000 workers from Khan's PTI party who travelled to Islamabad on Sunday to participate in the sit-in in response to their leader's "final call" to protest against the government.

Khan, the PTI's founder, has been imprisoned since August 2023 and is facing dozens of criminal cases. Bibi was also jailed for nine months this year before being released in October.

The protesters, who managed to reach central Islamabad despite roadblocks set up across the country by the government, called for Khan's release among other demands. Bibi led the protest alongside Ali Amin Gandapur, the PTI chief minister of Khyber Pakhtunkhwa province.

When protesters reached the planned site of the sit-in on Tuesday afternoon, paramilitary forces reportedly opened fire to disperse the crowd.

Later that evening, law enforcement launched a two-hour operation that cleared

the area. Both Bibi and Gandapur left for Khyber Pakhtunkhwa that same night.

The PTI issued a statement announcing the suspension of the sit-in for the "time being" and said at least eight of its supporters had been killed by authorities.

However, Information Minister Attaullah Tarar along with Planning Development Minister Ahsan Iqbal categorically rejected the assertion that law enforcement personnel used any live munitions or that any PTI worker had died.

Tarar, speaking at a news conference held in Islamabad for foreign media, said hospital authorities confirmed that they did not receive any bodies.

"The health department has issued two statements, one from Poly Clinic and another from PIMS Hospital, stating there have been no dead bodies," Tarar said, answering a query from Al Jazeera and referring to two of the largest public hospitals in Islamabad.

The casualty count remains in dispute with PTI leaders issuing contradictory statements, alleging deaths ranging from 10 to 200.

Hospital authorities have refused to share details of the injured and dead, telling Al Jazeera that they were "forbidden" from sharing information, a charge that the government denied. The government added that fake lists were circulating online.

"There was a fake list published on social media about the injured and dead, but it is incorrect. PTI is just trying to do politics on the dead and looking for bodies here and there," Tarar told the media on Thursday. The controversy deepened when journalist Matiullah Jan, a vocal critic of Pakistan's military, was arrested.

Jan had reportedly been investigating the alleged deaths during the protest for his YouTube channel. An initial police report against him accuses him of drug trafficking, "terrorism" and assaulting police officers.

The government, led by the Pakistan Muslim League-Nawaz (PMLN), came to power in February after the PTI refused to form a government despite its candidates winning the most National Assembly seats (93). The party alleged electoral rigging by the military to undermine its mandate.

The PMLN subsequently formed a coalition government but has faced fierce resistance from the PTI, which has staged four major protests in as many months, demanding Khan's release and challenging the credibility of the election results.

Health benefits of cutting down on sugar

Too much sugar in your diet can have spike in blood sugar levels also quickly a significant impact on your health, increasing your risk of serious health conditions and affecting your wellbeing too. The NHS recommends no more than 30 grams of sugar per day, which is roughly five rounded teaspoons of sugar.

By reducing how much sugar you consume you can improve your health in a host of ways. Here are some benefits of cutting back on sugar:

1. Maintain a healthy weight

Foods and drinks containing high levels of sugar (eg cakes, pastries, fizzy drinks, fruit juices) or highly processed carbohydrates have a high glycaemic index. This means they're quickly digested and consequently the feeling of fullness goes away faster. That makes it more likely that you'll eat again sooner or eat larger portions. This further increases your likelihood of putting on weight.

2. Avoid crashing energy levels

Sugary foods and drinks quickly increase the level of sugar in your blood, which gives you a burst of energy. However, this drops – this is called a crash. A high-sugar diet can, therefore, cause daily crashes and erratic energy levels, leaving you feeling tired and irritable.

3. Enjoy clearer, more youthful skin

A high-sugar diet can cause hormonal imbalances that affect your skin, specifically triggering acne. High sugar levels in your body can also damage collagen in your skin through a process called glycation.

When collagen is damaged by a highsugar diet, it can make vour skin appear more aged. Reducing how much sugar you consume can, therefore, improve your skin health.

4. Reduce your risk of type 2 diabetes

Whenever you eat a meal, it's broken down by your digestive system and sugar is released into your bloodstream. In response to this increase in blood sugar levels, your pancreas produces the hormone insulin to bring your blood sugar levels back down. However, if your diet is high in sugar, your body can become less sensitive to insulin – this is called insulin

resistance and can lead to prediabetes. Insulin resistance triggers a vicious cycle where your pancreas produces even more insulin as it detects that your blood sugar levels aren't reducing as quickly and as much as they should. Eventually, the insulin-producing cells in your pancreas can wear out, causing type 2 diabetes. A diet low in sugar can help protect your pancreas and prevent insulin resistance, prediabetes and type 2 diabetes.

5. Protect your dental health

Bacteria that naturally live in your mouth feed off the food you eat. This leads to dental plaque, a slimy film of bacteria that coats your teeth.

These bacteria produce acid as a byproduct of digesting the sugar in your food. The more sugar in your diet, the more acid is produced, which can eat away at the hard outer coating of your teeth (enamel). This leads to cavities, and can also irritate your gums, leading to gingivitis and gum disease. Gum disease, in particular, is linked to an increased risk of several serious health conditions, including diabetes, heart disease, heart attack, stroke and cancer.





'Staincliffe Junior School will continue to improve'

The Head Teacher at Staincliffe Junior School has outlined his high aspirations for the school.

Paul Dixon, who took over the headship in April 2020 during the Covid crisis following the retirement of the previous head, said the school is committed to delivering a juxtaposition of positive outcomes for children.

Sarah Hemmingway, a Year Group Leader in Maths is held in high regard along with Zuhair Daji, teaching assistant Naseem Shafi and Laura Parks, who constantly encourages children to read.

Although he recently retired, Mr Tiplady, who has taught children who went on to become architects, who helped design and build stadiums for the 2022 World Cup in Qatar, Doctors, academics and journalists, is also on hand to help out.

Such was his impact; countless children are still benefitting from his influence with one of his former students, Farida Nurgat of Nurgat tuition, credited Mr Tiplady with helping improve her confidence and teaching in such a manner, Farida now teaches students worldwide, from Dewsbury, with many going on to study at prestigious institutions such as Oxford University.

However, Mr Dixon is keen to stress, for him, it is a team game.

"It all comes down to teamwork. It is everybody from governors to parents to the kids themselves and the staffall pulling in that same direction. We are very much a family orientated school with an emphasis on helping children to understand that education is the passport to success."

Most intriguing of all, however, is the appointment of John Broadhead as the Chair of Governers. Indeed, his background and experience along with that of former inspirational and long-serving Chair, Moin Patel, will only serve to hold the school in good stead.

Mr Broadhead attended Batley Grammar School and after joining the Ministry of Defence in 1963 took a First Class degree in Modern European History. He served in Northern Ireland, Hong Kong, the Middle East and spent most of his later career as a senior civil servant in Whitehall.

"Over the last ten years we have developed a really strong governing body which reflects all parts of the community including professional people. It's a very cohesive governing body, better than any governing body that I've been involved in. I think that gives the teachers and the head teacher a great deal of support and confidence.

"They've explained the direction they are going in and the governors are happy with it. That is team work. There is a need for enrichment and not just focus entirely with the three R's but to look outwards, to go and find things that will broaden their horizons in their education and think about how they might progress in further education or employment."

When asked about the school's Ofsted report, which was deemed as 'Good'. Dixon speaks with an endearing form of boyish enthusiasm along with a great deal of honesty. His first inspection took place just before the harrowing events that led to the suicide of head teacher, Ruth Perry. A coroner concluded that an Ofsted inspection of Caversham Primary School, in Reading, had contributed to the suicide of Mrs Perry, 53, as she waited the publication of a report downgrading her school from outstanding to the bottom category, inadequate. The coroner said the

inspection had "lacked fairness, respect and sensitivity" and was at times "rude and intimidating".

"It was my first one as a head teacher so you want it to go well. This happened before the shocking and devastating events involving Ruth Perry. There was enough noise about Ofsted and how intrusive it is and the pressurised environment it causes and the knock on affect it can have on people's careers and livelihoods," said Mr Dixon.


"If it goes wrong it can have a devastating impact. It's the head teacher who ultimately is accountable for it. If it goes south, it's the head teachers name at the end of that report. The worse thing that can happen is the school is told that you can no longer lead and manage it yourselves, so we now need somebody to come in and manage it for you and put the head teacher on gardening leave.

Dixon is proud of everything at the school, from the impressive, refurbished library to the uplifting and inspiring images and quotes across the school, whilst acknowledging the financial support given to him by the governing board. No doubt, the school will continue to improve, whilst attracting more local talent.



ઈઝરાઈલના વડાપ્રધાન નેતાન્યહ્ સામે ધરપકડ વોરંટ
